## 1 Welcome, Present and Apologies

**1a** Mac welcomed everyone to the meeting. Apologies were accepted from RS, CS and KV. IE sent apologies, received later.

## 7 Minutes and Actions from Previous Meeting

- 7a MC had reviewed the RE curriculum and had also cross-referenced the policy with the school website. It was noted that the policy suggested that there would be links for parents on the website that were not there.
- **7b** PD had provided a written SEND report on governorhub. He noted that SEND was increasing nationally year-on-year and the school was following the same trend. At the end of the previous academic year 26% of the school had SEN, this was not the highest percentage in the city but one of the highest.
- **7c** Similarly, the school had a high number of EHCPs in relation to other Southampton schools.
- 7d PD had also attended the SIP SEND & Inclusion conference with the SENDCO in January. This had proved very useful and would contribute to his discussions with the SENDCO during his monitoring as link governor.
- **7e** The Local Offer & SEND Policy for 2022 was currently with Mrs Roberts and would be shared with the board for approval.

Q: How is the school coping with the current levels of SEN?

A: Mrs Roberts is now back in full time, so KV does not need to support in the same way as the previous academic year. There is an unseen impact on the school, for example when SLT are needed to support children with SEN following an incident.

**9a** All governors were reminded to undertake safeguarding training this year. The Key would soon be releasing training for governors, and this would be shared by

  - 4. To reduce (to below national figures) persistent absences across the school
  - 5. To further develop personal wellbeing for children and adults including leadership at Banister through the use of LiM
